General Consent Form

Prabha's in-depth homeopathic training and experience includes an apprenticeship with an experienced homeopath in Hyderabad, India as well as working in various charitable homeopathic dispensaries, which provided her an opportunity to treat various medical conditions and diseases.

Homeopathy is an alternative system of medicine which is based on treating the individual in a holistic manner. A homeopath finds an appropriate homeopathic remedy taking into consideration, the person's physical, mental & emotional conditions, in relation to their life situations.

The fundamental guiding principle of homeopathic system is "like cures like". This means, that any substance capable of producing symptoms in a healthy individual is capable of removing the similar set of symptoms during sickness when given in a very diluted homeopathically prepared doses. Homeopathic remedies are derived from various sources like plant, mineral and animals and prepared by an extensive dilution process called potentization. Such remedies, when administered on a dis-eased person, trigger the body's natural system of healing. This is based on the theory that every living being has self-healing and self-preservation properties and since symptoms in the sickness are produced by the body, they will also be removed by the body provided this self-healing property is stimulated and enhanced.

During this treatment process, each individual may react differently to the treatment, depending on their own state of vitality and there may be a possibility of aggravation of the symptoms, or sometimes the old symptoms may reappear as a part of healing process. A homeopath does not perform any form of medical examination, diagnosis or operative procedures. The goal of this system is to lead the individual towards general wellness and elevated state of health.

Homeopathy is alternative or complementary to healing arts that are licensed by the State of California. The homeopathic services are provided under the Sections 2053.5 and 2053.6 of California's Businesses and Professions Code. The California legislature passed Senate Bill 577, which requires all alternative health care practitioners in the state of California to disclose information to their clients about their practice. This bill is really a consumer protection bill designed to ensure that consumers of non-licensed health care practices have sufficient information about the practitioner they're working with, before entering into a working agreement.
